## TERMS OF USE

These Terms of Use shall govern the use of the services offered by NuriFlex Holdings Inc and NuriFlex World PTE, LTD. (collectively, "Nuriflex") at <a href="https://nuritopia.io">https://nuritopia.io</a>, and any other site or mobile application that may be operated by or for Nuriflex (the "Services"). Please read these Terms of Use before using the Services. Use of the Services constitutes an agreement to all terms and conditions in these Terms of Use. By using the Services you represent, warrant, understand, agree to and accept all terms and conditions contained in these Terms of Use. If you object to anything in these Terms of Use or <a href="the Privacy Policy">the Privacy Policy</a>, do not use the Service. These Terms of Use are subject to change at any time, effective upon posting through the Services or on the mobile application related to the Services, and your use of the Services after such posting will constitute acceptance by you of such changes.

#### **General Terms**

Nuriflex provides a metaverse that offers users ("you", "User" or "Users") a way to authentically forge a social connection in a virtual environment and an opportunity to be rewarded by participating in both real-life and fantastical activities. Users do hereby represent, understand and expressly agree that Nuriflex does not have control over the quality, timing, legality or any other aspect whatsoever of the actions or statements of any Users. All Users do hereby expressly agree not to hold Nuriflex (or Nuriflex's members, managers, directors, agents, assigns, representatives, advertisers or employees) liable for any claims relating to or resulting from any products or services which originated through or is otherwise relating to any content posted on or through the Services or any relationships or other contact initiated through use of the Services and Nuriflex expressly disclaims any liability whatsoever for any damage, suits, claims, and/or controversies that have arisen or may arise, whether known or unknown therefrom.

The Services are intended for individual Users only. Registration by a business or for any commercial purposes is strictly prohibited.

#### **Public Areas**

The arbitration shall be conducted in British Columbia, Canada, and judgment on the arbitration award may be entered into any court having jurisdiction thereof. Either you or Nuriflex may seek any interim or preliminary relief from a court of competent jurisdiction in British Columbia, Canada, necessary to protect the rights of property for you or Nuriflex pending the completion of arbitration.

#### **General Provisions**

Failure by Nuriflex to enforce any provision(s) of these Terms of Use shall not be construed as a waiver of any provision or right. These Terms of Use, and all other aspects of use of the Services, shall be governed by and construed in accordance with the laws of British Columbia, Canada, without regard to its conflict of laws rules. Any controversy or claim that is not subject to the Arbitration provision set forth in these Terms of Use, other than action for a specific performance or for injunctive relief brought by Nuriflex, shall be exclusively brought in the federal, state, or local courts located in British Columbia, Canada; and, with regard to such claims and disputes, Users hereby irrevocably (i) submit to the exercise of personal jurisdiction over them by these courts, and (ii) waive any jurisdictional, venue or inconvenient forum objections to such courts. These Terms of Use constitute the entire agreement between Users and Nuriflex with respect to the Services. If any provision of these Terms of Use is found to be invalid or unenforceable, the remaining provisions shall be enforced to the fullest extent possible, and the remaining Terms of Use shall remain in full force and effect. These Terms of Use inure to the benefit of Nuriflex, its successors and assigns.
